A 4-day intensive tutorial in the therapeutic application of *animal normalization techniques (ANT)*

These techniques use the principles of Thomas Myer's Anatomy Trains and fascial lines, motion testing, and motion in relation to musculo-skeletal and visceral dysfunctions..

Comparisons between humans and animals. Emphasis will be placed on palpatory and osteopathic skills.

This course will cover facial lines in relationship to lymph:

- Explaining fascial trains and lines from Thomas Myers, LMT, its application to humans and animals in regards to "neurological fascial innervation" (i.e., "Breaker Theory").
- Arthrokinematics in relationship to fascial lines and use in the practical world.
- Review of connective tissue inter-relationship with "shock" (sympathetic overdrive), lymph stagnation, and gluten impaction.
- Principles of Osteopathy - Discussing the highest level of protective hierarchy of the body in regards to blood, lymph, and fascia!
- Instruction of dura protocol and it's relationship to cranial-sacral techniques
- Combination of fascial lines with the "neurological gait cycles", and foot reflexology
